My research interest within the field of gastroenterology is focused on Inflammatory Bowel Diseases, specifically dysplasia in IBD and perianal disease in Crohn's disease. My mentor, Dr. Lazarev and I have reported on the novel histopathological finding of serrated epithelial change, a potential early marker for colonic dysplasia in IBD patients. We are continuing this work looking closer at the genetic profile of serrated epithelial change compared to the normal surrounding mucosa and the metachronous neoplasia that develops. I received a large Helmsley Trust grant to investigate the use of novel therapies for the treatment of perianal Crohn's disease under the mentorship of Dr. Florin Selaru. This is a multidisciplinary team involving a bioengineer, radiologist, surgeon, basic scientist and epidemiologist that I have been leading for the past 2 years.

We help to fill providers endoscopy blocks by targeting direct access patients to gaps in the schedule. We are working to improve flow and efficiency in our ambulatory endoscopy centers and improve safety, quality and decrease the same day

cancellation rates. We are working on quality metrics in endoscopy including the ability to report adenoma detection rate for each provider.
